Sub: RFP No. NPCIL/BSR-220MWe/2024/01 for Request for Proposal from Indian Users for 220 MWe PHWR Bharat Small Reactors (BSRs) In Brown/Green field sites offered by INDUSTRIES (For consumption of electricity for their own use)

This has reference to the subject Request for Proposal. Request for proposal was floated by NPCIL on 31.12.2024 inviting proposals from private / public industries for setting up 220 MWe Bharat Small Reactor (BSR).

A pre-proposal meeting was organized on 12.02.2025 with participation by around 70 delegates from 27 industries. Queries were received from various industries on the RFP and around 700 queries were responded by 17.04.2025.

M/s. Hindalco Industries Ltd, M/s. Jindal Steel & Power Ltd, M/s. Tata Power Co. Ltd and M/s. Reliance Industries Ltd, had submitted the documents specified in the RFP for signing Non-disclosure Agreement (NDA) and collected tentative BOQ, plant performance data and O&M expenditure data after signing NDA. M/s. JSW Energy Ltd and M/s Adani Power Ltd have submitted documents for signing NDA and same are under evaluation and further processing.

Above Industries have also identified probable sites for BSR and have submitted preliminary site report of 16 sites in different states viz. 5 sites in Gujarat, 4 sites in M.P., 3 sites in Odisha, 2 sites in A.P., and 1 site each in Jharkhand and Chhatisgarh.

Based on the request received from some of the above industries, NPCIL has issued letters to the state governments of Gujarat, MP and Odisha requesting to extend necessary support for site investigation activities and, land & water allocation for setting up BSR.

The last date for submission of proposals by Industries is September 30, 2025. However, the above Industries have submitted request to extend the deadline for submission of proposal, as they need more time to evaluate the respective sites and work out the CAPEX and O&M cost of BSR based

on the data provided by NPCIL for submission of proposal and proceed further on activities for setting up BSR.

As the global business landscape shifts decisively toward green energy, Indian industries are increasingly recognizing the strategic importance of securing carbon-free, clean power for their operations. This transition is not only critical for maintaining global competitiveness but also essential to avoid potential trade barriers linked to carbon-intensive exports.

BSR initiative being part of NPCIL's broader commitment to support India's clean energy transition, leveraging NPCIL's expertise to drive sustainable industrial growth and to facilitate wider participation in this important initiative, in larger interest of the industries it has been decided to extend the deadline for submission of proposal.

For Industries who have already signed the NDA / for those who have submitted documents and are under process of signing the NDA, the further process of ongoing interactions will be continued. Also, few more industries have shown interest in setting up BSR and are in communication with NPCIL.

In view of the above, due date for submission of proposal against subject Request for Proposal (RFP) have been rescheduled as per details given below:
